In the concern school for pre primary devision, L.K.G., U.K.G. 1-1 this manners total - 2 classes are working in that total 19 students are studying. IN year 16-17 3 academic employees were working. For that total cost of Rs. 169722/- as per details shown in Table - B expense is incurred.

Fro lower primary standard 1 to 5 total 1-1 thus total 05 classes are working. In these total 99 students are studying. In year 16-17 total 6 academic employees are working. For that total salary expenses of rs. 832916/- is shown as per above details.

For higher primary standard 6 to 8 total 1-1 thus 03 classes are working working. In these total 43 students are studying. In year 16-17 total 4 academic employees are working. For that total salary expenses of Rs. 534905/- is shown as per above details.

For secondary Division standard 9 to 10 total 1-1 thus 02 classes are working working. In these total 20 students are studying. In year 16-17 total 12 academic employees are working. For that total salary expenses of Rs. 1949817/- is shown as per above details.

Besides this for concern school own Preprimary, Lower Primary, Higher, Primary, Secondary thus in total four divisions non-academic employees salary expesens as per details Table -B Rs. 1421090/- amount is mentioned.

And details wise cost of division wise data for concern schools as per Table A is incurred, such is informed from organization, above shown presentation related committee have concluded below shown manners conclusions.

Concern school building is belongs to ownership of Shri B. C. Rajpot and demand for rent is not made.





In Concern school for Pre-primary division as per above shown details 2 classes are working. In these in eyar 16-17 total 19 students are styding. NCPCR (National Commission for protection of child right) for Pre parimary Devision for regularory guidelines as per 4.B.4 per 20 students 1 teacher and 1 care giver shall be receivable. Here in Pre primary Devision 3 Academic employees are mentioned. Its salary cost is worth Rs. 169722/- shall be valid. In the said division NCPCR (National Commission for protection of child right) in pre primary Division accordingly regularory guidelines as per 4.B.4 per 40 students here total 19 students are styding. Maximum worthy strength is 40 students but against that only 19 students are studying, so the maximum admission worthy strength 50 % this means upon 20 students allotment is made so Rs. 8486/- per student salray expenses is worth for its validation.

In concern schools in lower primary devision as per above shown 05 classes are working, in year 16-17 total 99 students are studying. Under free and compulsory education Act 2009 its clause 25 against 30 students 1 teacher is worth for receivable. Here in lower Primary Division 6 Academic employees are mentioned. Under that Rs. 832916/- salary cost is worth valid. So this will be alloted among 99 students so per student Rs. 8413/-salary cost is being valid /acceptable cost.

In concern schools in Higher primary devision as per above shown 03 classes are working, in year 16-17 total 43 students are studying. Under free and compulsory education Act 2009 its clause 25 against 35 students 1 teacher is worth for receivable. Here in Higher Primary Division 4 Academic employees are mentioned. Under that Rs. 534905/- salary cost is worth valid. In the said Division Under free and compulsory education Act 2009 its clause 25 against 105 students simply 43 students are styding here, so maximum admission worth strength is of 50 % rates this means upon 53 students allotment shall be made so per student only Rs. 10093 Salary cost is worth valid.

In concern schools in Higher secondary division 02 classes is working. In year 16-17 total 20 students are styding and for that from the said organization 12 academic employees are shown. Schools students in their academic qualifty for its additional and activities relates per calss fixed accordingly concern board 3 teachers is receivable up to its twice times or in fact appointed teachers strengths among wheih considering its minimum strength 6 teachers shall be worth receivable. For the said division 12 Academic employees salary cost is Rs. 1948817/- is menionted. Considering its average salary Rs. 162401/- to 5 teachers Rs. 812005/- salary cost shall be worth valid. In the said division as per Secondary Education Rules 1975 as per act Rule 19 against its maximum admission 120 students only





20 students are styding here so worth maximum admision strength its 50 % this means against 60 students allotment shall be made so only Rs. 13533/- salary cost per stydent shall be worth valid.

For entire division of concern school 25 non Academic employees are mentioned. Fro that against salary cost Rs. 1421090/- is mentioned. Among that considering the strength of students similar to maximum 15 non-academic employees should be worth valid. Therefore worth acceptance Rs. 852660/- salary cost is incurred, so this amount shall be alloted among total students 232 who are studying in schools hence per student Rs. 3675/-salary cost is worth valid.

Bsides that from schools for entire divisions as per coloumn 3 of Table -A school food exp. Rs. 1123435/- and student univorm Rs. 252772 and transportation exp. and School bus Rs. 145200/- shown. Under Gujarat Self relient School (Fee reguation) Act 2017 for Gujarat Self relient School (Fee reguation) Rules 2017 as per Rule 2(4) the cost which is not included in to definition of fee so the said cost shall not be acceptable or valid. Its and in the said division except the above shown details other misc. cost Rs. 3407088/- should not worth validation. That is allotted among 232 total students of school hence per student Rs. 14685/- cost shall be worth valid.

This manners in Pre primary Division as per above said student for academic employees salary cost Rs. 8486 and for other mis. cost Rs. 14685/- this manners total Rs. 23171/- cost shall be considered worth acceptable and valid.

This manners for lower Primary division for above shown per students academic employees salary cost 8413, for non academic employees salary cost Rs. 3675 and for other cost Rs. 14685/- this manners total Rs. 26773/- is worth valid and acceptable per student.

This manners for Higher primary Division as per above said student for academic employees salary cost Rs. 10093, for non academic employees salary cost Rs. 3675/- and for other misx. cost Rs. 14685/- this manners total Rs. 28453/- is worth acceptable and valid per student so this amount is per student cost.

This manners for Higher Division for above shown per student salary cost of academic employees worth Rs. 13533/-, for Non Academic employees salary cost Rs. 3675/- and for other mis. expenses Rs. 14685/- this manners total Rs. 31893/- cost per student is worth acceptance and vlid cost per one student.
